## E-7-18/19-2 NEW VOLUNTEERS

### 4.2 CIO Constitutional Requirement re Rotation & Re-election of CIO Trustees

The requirement is that ".... after the first AGM at every subsequent AGM one third of the charity trustees shall retire from office . If the number of charity trustees is not three or a multiple of three, then the number nearest to one third shall retire from office..." These people can then be re-appointed by the membership at the AGM if they wish to continue to give their services as trustees. The retirement selction to be based on length of service from first appointment or re-appointmant at an AGM.

We have applied this since our first AGM 28 July 2016.

Meeting those requirements means that Chris and Ian are the trustees selected for this AGM

As per an action from the last meeting (Section 3.2) Ian was successful in getting approval for a late entry for Cumbria teams from Alan Batchelor – event organiser –for the cup being held at Cheadle 15 16 June. Ian & Gavin were successful in getting two teams – schools year 6 and Year 9/10. They had a very enjoyable event.

## E-7-18/19-9 JUNIOR DEVELOPMENT

## 9.1 ACADEMY COACHING

The coaching will be continued in the forthcoming season with Gavin as coach, supported by Ian on administrative/financial aspects.

We have concerns about the support for this from Juniors and had a solid discussion about what we can do to improve the situation. No positive decisions resulted and the discussions need to continue. We encourage Ian & Gavin to maintain the record of attendance started some time ago – review of it will help the work.

This is the only aspect of the original Junior Plan that is still fully operational

## 9.2 MANAGEMENT OF JUNIOR ACTIVITIES

We desperately need an overall manager to mastermind our junior scene – competitions and player development. It will be seen from these and other minutes that we are firefighting and doing things in a bitty way with our few committee members and we are losing out on many aspects of our Junior Development Plan in a serious way as everyone knows – a situation we must reverse as soon as possible. We have no one presently on the Exec willing to take up that position.

The NWRF recognises and is sympathetic to our situation and this season has kindly awarded us with a £3000 grant to help us try to resolve the problems and concerns we have – as indicated to the forum by Tom who convinced the members, Including two guest members from ES, that we would be working on review & resolution of our problems in a serious way.

At the time of getting the grant we only had four members on the Exec. committee each with other jobs on it – too few to do anything extra in a meaningful way – so decided to wait for the results of our recruitment drive in the hope that we would get good support from clubs with more volunteers who may have helped with this work. The limited additional support we have received, as detailed above, is very much appreciated and helps the situation but does not resolve our probems – we still need more support.

Tom has a concern that to date we have not moved forward at all and are still sitting with the grant untouched in the account – we need to try and do something soon in the junior development field, accepting the volunteer situation as is, to justify to NWRF that it made the right decision to help us.

## E-7-18/19-10 WORKINGTON JUNIOR SQUASH CLUB

As a result of contact with the club as advised in the action section 3.2 above – we were advised that everything promised had been done with the exception that the club's membership subscription to ES had not been paid, in fact there had been no contact with Louise at ES at all, as was promised. Apologies were given with a commitment to contact Louise ASAP- this will be checked – Action Tom

## E-7-18/19-11 FINANCIAL – MANAGEMENT ACCOUNTS

Chris presented the accounts and effectively they are completed for presentation to the membership at the AGM.There are a few loose ends and small payments to be made to end the season.

There are no concerns. The account stands at a very comfortable level of over £13000 which is excellent but for the wrong reasons including not one penny spend on Junior Inter County events – resulting from no team entries this season.

## E-7-18-19-12 MARKING & REFEREEING INSTRUCTION

There are indications that there may be some support for one or more M&R instruction/awareness workshops – maybe one specifically for juniors or an open session for all, or both. The sessions will be for basic understanding of the rules, their interpretation and the formal requirements associated with markers calls and recording processes. The workshop will not be to qualify people as M&Rs – such qualification would be the next step for all interested in that.

We are already holding a stock of 60 copies of a very good **How to Mark & Referee** handbook written by Alan Batchelor (Cheshire Squash & NWRF) that would be a very good hand-out for such sessions. We issued these to all of our juniors at a Junior County Closed event a couple of seasons ago.

## APPENDIX.

## England Squash, ICC Masters, Mens O55 & 65, Finals, 22-23Jun19

Both the O55s and O65s were runner-ups in their respective regional stage events and got through to the finals in Coventry of the weekend of 22/23 June 2019. Both competitions were held on an 8-team 'Monrad' system, where all teams play 3 games irrespective of winning or losing. Effectively it is a knockout competition; quarter-finals, semi's and final.

## **O55**s

Unfortunately, the O55's only travelled with only four players (for a five man team) due to injury and non-availability. The team consisted of:

## Collis Sheik

Dave & Digger both won their first games against Surrey 3-0. Andrew narrowly lost 2-3 and Collis 1-3, the team losing the match 2-3. So the team were automatically playing for a position in the bottom four at this stage.

They played Somerset in the second round, and despite only having 4 players, they won 3-2; Collis again lost 1-3, but Andrew, Dave and Digger all won 3-0.

At this stage, the team elected not to play their third round match for the  $5^{th}/6^{th}$  position, and allowed Somerset to go through.

## **O65**s

With Ronnie Bell not available, the O65s (reigning National Champions) travelled with four players for their three-man team:

Terry Belshaw Chris Lilley Trevor Musson Phil Leek

First round was against Hampshire, winners of their regional stage. Trevor was first one but lost 0-3. Terry won his match quite convincingly 3-1. Unfortunately Chris was well beaten 0-3 against a much better player. So again like the O55s, the team were left fighting for a position in the bottom four.

The second round against Yorkshire was again lost: Phil lost 0-3, Terry won 3-1, and despite a close five setter, Chris lost 2-3.

In the final round against host county Warwickshire, Trevor lost his game, Terry won, and Chris managed to win 3-1. The team win meant that we finished in 7<sup>th</sup> position.
